Bookings are not confirmed without full payment. All tickets must be collected from the Alice Springs Turf Club (ASTC) Administration Office prior to race day. Dress standards apply in members areas. Seating allocation is at the discretion of the ASTC. **NOTE:** Luncheon is alternate drop - entrée is served at 1.00pm, main course is served at 1.45pm, dessert is served at 2.30pm. *Arrival outside of these times will result in forfeiting any part of the meal missed.*

ASTC reserves the right not to sell tickets to any person, agent or company. ASTC is not liable for any loss, inconvenience, damage, additional expense, injury, delay or any other claim in relation to changes to event information, program, including the cancellation or rescheduling of events due to unforeseen circumstances. The ASTC reserves the right to alter the date, venue, entertainment and activities as advertised without prior notice. All clients who have booked tickets indemnify the ASTC against liability for or in respect of any claims, demands, actions, suits or proceedings, costs, expenses, loss, damage, personal injury or death of any person arising out or in connection with the execution of work at the facility, the use of the facility by the Client or any act or omission of the Client, or any of their guests, invitees, employees, contractors or agents.

RACE MEETING POSTPONEMENT

If a race meeting is postponed on the day prior to the event it will continue as a Phantom race-day. If a race meeting is postponed the day prior to the event it will also be transferred to the postponed date with no refund forthcoming.

RACE-DAY PROGRAM

The ASTC reserves the right to alter the race-day program without notice, under any circumstances. While the ASTC takes every reasonable step to ensure the race-day runs to schedule, the ASTC accepts no liability for any change for any reasonable cause, including but not limited to, wet weather.

ALCOHOL POLICY

i. In order to comply with its legal and social responsibilities, ASTC has a policy on responsible service of alcohol ("RSA Policy").

The RSA policy will be observed and applied by the ASTC staff with respect to all guests and events.

ii. The client is responsible for the behaviour of all guests attending the event. ASTC reserves the right in its absolute direction to discontinue the service of liquor and/or cancel the event at any time, either before or during the event, if an actual or threatened breach of the RSA policy or any applicable laws occurs in relation to the service or supply of alcohol, or behaviour of guests.

iii. The taking of illegal drugs will not be tolerated at the ASTC. The club does not condone the use or possession of illegal drugs in their possession and will be referred to the appropriate authorities.

LOST OR STOLEN TICKETS

i. Replacement for lost or stolen ticket will attract the standard General Admission or Members' Guest admission charges applicable to the Race-day.

ii. Only written requests giving the identification number of the lost ticket will be accepted.

iii. You must arrange to collect replacement ticket from the ASTC race-day Office prior to the Race-day.

MISCELLANEOUS

i. You should be aware that you and your guests' participation in the race-day may be photographed and/or recorded and that all such material may be used by us for advertising and promotional purposes. You assign copyright or any such material to the ASTC.

ii. Tables for a maximum of ten guests, bookings for less than ten guests will be required to share tables.

iii. All admission and dining prices are inclusive of GST.
